MEMORANDUM OF UNDERSTANDING (MOU)

And

UMA NATH SINGH AUTONOMOUS STATE MEDICAL COLLEGE (UNS ASMC), JAUNPUR whose registered office is at SIDDIOPUR, SHAHGANJ ROAD, JAUNPUR, UTTAR PRADESH- 222003 referred to as SECOND PART.

ARTICLE 1: BACKGROUND AND PURPOSE

A. About Veer Bahadur Singh Purvanchal University, Jaunpur

- Purvanchal University, Jaunpur renamed as Veer Bahadur Singh Purvanchal University (VBSPU) in the honour of Late Shri Veer Bahadur Singh, former Chief Minister of the Uttar Pradesh State, was established on 2nd October 1987 as an affiliating university under U.P. State University Act 1973. Continuous qualitative and quantitative growth, excellence in academic and administrative activities, transparent and efficient academic administration have been some of the distinct characteristics on the basis of which the university emerged as one among the leading universities in Northern India.
- The beginning of two-years full-time residential MBA course in 1990 was one of the first steps towards making change in the character of the university from affiliating to affiliating cumresidential university.

The Institute is located near 2.0 KM from Veer Bahadur Singh Purvanchal University in Siddigpur on Shahganj Jaunpur road. The campus of Institute spans in 50 acres of large area with incampus hospital, academic building, administrative building, student and faculty residential areas.

ARTICLE 2: AREAS OF COLLABORATION

The parties hereby agree to work collaboratively on following points for the effective and efficient engagement by fulfilling the purpose of this MoU towards strengthening and streamlining teaching, research in scientific and technology development, innovation and entrepreneurship. The mutually agreed activities by and between the parties are as under:

A. RESEARCH & DEVELOPMENT

Faculties, Research Scholars, and Students (PG & UG) from VBSPU and UNS ASMC may partner for collaborations in research activities, internship, data collection and jointly develop research

projects and publications. In case of the financial assistance received from the funding agencies to be utilized for the project work only as set out in the project proposal.

B. FACULTY EXCHANGE PROGRAMME

The experts/faculties of VBSPU and UNS ASMC will be recognized as visiting faculty and can be utilized in teaching in their concerned field or subject. Hence, UNS ASMC will assign their faculty and medical staff to provide their services/consultancy at Health Centre of VBSPU for University staff as social service.

C. SOCIAL SERVICES/OUTREACH PROGRAMME

Both VBSPU and UNS ASMC may partner for collaborations in outreach program such as monthly Medical Camp, Blood Donation Camp and different awareness programs with their faculty and students.

D. ORGANIZING ONLINE/OFFLINE SEMINARS/CONFERENCES, WORKSHOPS, FACULTY AND STUDENT DEVELOPMENT PROGRAMS.

Experts from VBSPU and UNS ASMC may partner for organizing online/offline Seminars/Conferences, Workshops, Training, Faculty and Student Development Programs on mutual key thrust areas.

E. JOINT CERTIFICATE/DIPLOMA PROGRAMME

The different faculty of VBSPU and UNS ASMC such as Applied Psychology, Pharmacy, Bio-Technology, Bio-Chemistry, Microbiology, Environment Science and Computer Science may partner for starting dual certificate, value added diploma courses in light of National Education Policy 2020 and for the welfare of society.

F. ORGANIZING CULTURAL/SOCIAL EVENTS FOR THE STUDENTS

Both **VBSPU** and **UNS ASMC** may partner for collaborations in organizing different sports, cultural, and social events for the holistic development of their students.

Further, it is also agreed that:

a. Faculties, Research Scholars, and Students from VBSPU and UNS ASMC may access the resources such as laboratories, facilities (hostel, library, e-resources, guest house, sport ground) during their official and academic visit of the institution with a nominal amount mutually decided by both parties.

b. UNS ASMC will give priority and available help to the VBSPU staff and students while visiting in hospital in medical help or emergency on providing valid identity card of the university.

ARTICLE 3: CO-ORDINATION AND NODAL OFFICER

 Both entities shall mutually decide and designate a nodal officer. The nodal officer will have responsibility for fulfilling the objectives of this agreement and also will carry out all activities mutually agreed by the parties.

ARTICLE 4: SCOPE

The Parties acknowledge and agree that the areas of collaboration are not exhaustive in nature and the Parties shall in good faith, negotiate to elaborate upon the areas of collaboration, including additional areas of collaboration as may be mutually agreed and the rights, responsibilities and obligations of each party in relation to each of the areas of collaboration. The Parties may, from time to time, execute addenda or modifications to this MOU to incorporate such additional scope of collaboration or discussions in accordance with *Article 2*.

ARTICLE 5: DURATION

- (a) This MoU is effective from the date on which it is signed by the Authorities/Registrar/Head of both the participating organizations to this MoU.
- (b) This MoU shall remain in full force and effect for a <u>period of 3 years from the date of signing of</u>
 <u>this MoU.</u>
- (c) Both the parties to this MoU shall decide whether to renew or terminate or amend any of the terms and conditions of this contract within the due date to the MoU and necessary communication to the effect be exchanged by both the parties, before the due date of this MoU.

ARTICLE 6: TERMS & CONDITIONS

6 (a) Finance

Both Parties shall be responsible to carry out the activities under the area of collaboration and new project, program, conference, seminar, training, workshops and like which is codesigned/organized by both the parties mentioned in article 2. The financial arrangements

• No alterations, additions or modification hereto shall be valid and binding unless the same are reduced to writing and signed by both the Parties.

6 (c) Confidentiality and Public Announcement:

- This MOU and all confidential information exchanged between the Parties pursuant to this MOU shall be held in confidence.
- Neither Party nor any of the affiliates shall make any public announcement about the MOU and or the scope of proposed engagement, without the prior written consent of the other Party.

6 (d) License and Intellectual Property Rights

- No license is granted under this MOU to either Party under any of the other Party's intellectual
 property rights, either expressly, by implication, inducement otherwise. Both Parties understand
 and acknowledge that grant of any such license shall always be expressive and in writing.
- Both parties will take all necessary steps to protect the knowledge documents and intellectual
 Properties generated during the process or shared by the parties.

6 (e) Conflict of Interest

Neither of the parties believes that the Collaboration contemplated by this MOU raise any actual or potential conflicts of interest. The parties agree that this MOU and the negotiation of the same (and any other agreements entered into in connection herewith) are independent of any past, present or potential future arrangements, and are not connected to an existing professional relationship between either of the parties.

ARTICLE 7: TERMINATION

This MOU shall also terminate without liability to either party if otherwise agreed to by the Parties in writing with a notice period of 1 month.

g (a) Governing Law and Jurisdiction

- All disputes and differences arising out of or in connection with this MOU shall be the first instance referred to arbitration by three (3) arbitrators, jointly appointed by Parties. The decision and award determined by such arbitration will be final and binding upon the Parties. The arbitration will be conducted in accordance with the Arbitration and Conciliation Act, 1996, as may be in force from time to time. The arbitration proceedings will be conducted in English and the seat of arbitration will be Prayagraj, U.P.
